

### **ACKNOWLEDGMENTS**

An empirical, fieldwork-based, and detail-oriented thesis like mine depends on contributions from hundreds of people. While I cannot do justice to all of them, I will try to mention all those individuals and collectives that played an important role in the process.

First and foremost, I owe thanks to my first supervisor, Mark Graham. He supported and enabled this research from day one—or actually, even before. Mark backed my application to the DPhil program at the Oxford Internet Institute and helped me secure a scholarship and funding for fieldwork. He has always been encouraging, responsive, and hands-on when needed, but he was never controlling or pushy. This balance made him, in my eyes, an ideal thesis supervisor. He alleviated my confusions through innumerous conversations, and wrote support letters and emails to pave my way through dozens of applications and submissions. As the master communicator that he is, Mark has particularly helped me understand how to frame and present my work. Finally, he helped me transition into a related postdoctoral position, allowing me to continue and extend my research rather seamlessly.

My second supervisor, Marc Ventresca, has played a much different but no less essential role. Time and again, Marc inspired me and opened my eyes to new literatures and new ways of thinking. Conversations with Marc are always mind-expanding and often mind-blowing, and this impact on my intellect goes far beyond what can be read in this thesis. Marc's knowledge is vast, and like no one else, he is able to explain and contextualize the origins and evolution of theory. Marc taught me to cherish values and principles that surpass careerism and the "publish or perish" dogma, such as curiosity, love of knowledge for knowledge's sake, and (what one might call) elegance of thought. He also facilitated a Stanford visit for me, which I am deeply grateful for.

Next, I want to acknowledge the 133 entrepreneurs, hub managers, and other entrepreneurship supporters who offered up their time for interviews and workshops in Kigali, Harare,

and Accra. I had never been to any of these cities, but each time, I was welcomed and offered unconditional (and free!) help and assistance. It was also humbling to hear such a rich set of entrepreneurial stories—brimming with aspiration, skill, grit, dedication, creativity, and curiosity. I am not one to lionize entrepreneurs, but it is also true that I have met many remarkable individuals, doing important and difficult work for their communities and nations. I feel very fortunate to have been witness to the processes of positive change that are underway in so many African cities, and to have engaged with many of the people driving this change.

Back in Oxford, the assessors of different versions and parts of the thesis have greatly shaped and improved the final product. Marc Ventresca and Vili Lehdonvirta were assessors for the transfer of status, helping me to broaden my perspective before fieldwork. At the confirmation stage, Vili and Tom Lawrence helped me back on the path to a coherent, doable, and sensible thesis (a path which I had very much lost at the time). I received informal mentoring and substantive feedback from a number of other scholars. I will mention Tuukka Toivonen first, as he embedded me into a research community on hubs (and similar organizations), and his suggestions also helped me arrive at many of the insights in chapter 5. Isis Hjorth has not only been a great friend throughout the doctorate, but also supported me directly as I grappled with qualitative methodology, coding, rigor, and the ethics of my thesis.
